

ONLINE TRADE LICENCE: KIRKEE CANTONMENT BOARD.

On the instructions of Ministry of Defence, Government of India Directorate General Defence Estates have developed standardized content for issue of trade Licence, mCollect, public grievance & redressal, water and sewerage, property tax, etc through e-Chhawani master portal for all the Cantonment Boards.

Objectives of the eChhawani portal is to provide online services to citizens, improve the efficiency of the current system from paper based towards paperless, enhance the revenue through transparency, unification of multiple systems on a single platform, etc.

In light of the above to facilitate traders in Kirkee Cantonment Board it has been planned to start process the trade licence to traders at their door step in phased manner. In first phase shops located in Kirkee Business Centre have been identified for initiation of trade licences from 01 Jan. 2021.

To enable smooth process all the traders are hereby requested to keep the following documents ready: -

- i. System built application form with photo.
- ii. Occupancy related documents
(Any one GLR / Agreement / Deed / Property tax / lease / license rent / or previous year trade licence / water bills)
- iii. Proof of identity
(Any one of Pan card, Passport, Adhar Card, Driving licence, Election voter ID / EPIC, CGHS / ECHS card)
- iv. Proof of Address
(Any one of telephone bills. Electricity, Licence of vehicle / Arms Licence, Water bills, Ration Card and Election Voter -ID)
- v. Self declaration by the individual.
- vi. Shop Act licence issued by State Government.
- vii. No due certificate from Revenue Section, Kirkee Cantonment Board.
- viii. FASSAI licence for sale of food articles.
- ix. For liquor shops licence from Maharashtra State Excise.
