Only online tenders will be accepted and no manual tender will be accepted and will be summarily rejected.

The E-Tender should be uploaded with the certified documentary proof of

1. Registration of concerned Department,
2. List of Works of similar nature in hand, executed and successfully completed with proper documentary proof,
3. Bank Solvency Certificate for a minimum of 25% of the estimated cost of work from Nationalized/ Scheduled Banks,
4. Income Tax Permanent Account Number/TAN, GST & EPF registration and
5. The list of technical staff employed and details of machinery possessed.
6. EMD in the form of Demand Draft/FDR drawn on Nationalized / Scheduled Bank or acknowledgement receipt in case NEFT/RTGS. The cost of the tender form (Non-refundable) to be paid in the form of Demand Draft drawn on Nationalized / Scheduled Bank or acknowledgement receipt in case NEFT/RTGS.

Other details and particular regarding conditions of Tenders can be had from the office of the Cantonment Board, Kirkee on working day during working hours. The Budget Provision (indicating the estimated cost of work) is purely tentative and not binding on the Cantonment Board/Chief Executive Officer to actually place work orders accordingly. The period of contract may change based on the assessment of the Board/Chief Executive Officer. All the above works will have **Third Party** inspection from time to time during the progress of work or as and when instructed by the CEO/Board. The charges for regular periodic Third-party inspection will be borne by the Board, but however charges for periodical tests to be carried as per the instructions of Third-Party inspectors will be contractor's responsibility.
