Before commencement of the meeting, Dr.Jayashree Katare, Additional District Magistrate who has been nominated by the District magistrate, Pune under section 12(3)(b) of the Cantonments Act, 2006 vide Order dated 23/12/2020 took Oath of allegiance to the Constitution of India on becoming Nominated Member of the Board.

1. CEO informed the Board that the Petitioner Shri Ramesh Bagawe, who has filed the Writ Petition (St) No.97752 of 2020 in the Hon'ble High Court, Mumbai, had sought urgent circulation for hearing of the said Writ Petition on 29/12/2020 before the Vacation Bench. Counsel Dr. Abhinav Chandrachud and Adv. Raksha Thakkar appeared on behalf of the Respondent Board 3 & 4 i.e the President of Kirkee Cantonment and Chief Executive Officer, Kirkee Cantonment Board. After hearing both the parties, the Hon'ble Bench passed an order that the election for the post of Vice President of Cantonment Board will be subject to the outcome of present Writ Petition. In view thereof, M/s Parinam Law Associates have vide their letter dated 29/12/2020 opined that the Cantonment Board can proceed with the election for the post of Vice President on 01 January 2021. However, the same will be subject to the outcome of present Writ Petition and the Writ Petition is listed before the regular bench on 05 January 2021 to be heard on merits.

Thereafter, the procedure of the Election of Vice President as per Election of Vice President of the Cantonment Board (Procedure) Rule, 2011 was read out by the CEO. Thereupon, the name of Ms. Kartiki Prakash Hivarkar was proposed by Shri Duryodhan T Bhapkar and seconded by Shri Abhay K Sawant.

Also, the name of Smt. Pooja Manish Anand was proposed by Smt Vaishali Kailas Pahilwan and seconded by Shri Manish Surendra Anand. Since two names have been nominated for election as Vice President, the President Cantonment Board declared that the elected members of the Board shall proceed to vote by ballot in accordance with rule 5(4) of the Election of Vice President of the Cantonments Board (Procedure) Rules, 2011. The ballot papers were shown to all the elected members and each elected member were asked to cast their vote for the candidate of their preference by affixing the stamp in front of the space provided against each candidate.

At this point Shri Girish Bapat, Hon'ble MP (Lok Sabha) and Shri Siddarath Shirole, Hon'ble MLA joined the meeting. They were welcomed by the President, Cantonment Board along with all the Board members.

The elected members proceeded to vote through ballot and after tendering the vote by each member, the ballot paper was folded and put in a box kept in the Board Hall in front of all present.

The President Cantonment Board then recorded the total number of votes polled by ballot and announced the number of votes secured by each candidate. According to the ballot vote, out of seven votes that were cast; four votes were cast in favour of Ms. Kartiki Prakash Hivarkar and three votes in favour of Smt. Pooja Manish Anand. As Ms. Kartiki Prakash Hivarkar secured the highest number of votes, the President, Cantonment Board declared Ms. Kartiki Prakash Hivarkar elected as the Vice President of Kirkee Cantonment Board subject to the outcome of the Writ Petition (St) No. 97752 of 2020.

Shri Kamlesh S Chaskar, Elected Member thanked Shri Duryodhan T Bhapkar whose resignation as Vice President was accepted by the Board in its meeting of 23/12/2020, for all his support during his tenure as VP and appreciated the commendable work done by him, especially during the Covid Pandemic such as providing food to the needy persons in the whole of Kirkee Cantonment area and providing Jetting Machine for spraying disinfectants in the Cantonment area. Shri Chaskar also congratulated Ms. Kartiki Prakash Hivarkar for becoming the first lady Vice President of Kirkee Cantonment Board.

Smt. Pooja Manish Anand, Elected Member wished New Year Greetings and conveyed her best wishes to Ms. Kartiki Prakash Hivarkar for becoming the first lady Vice President of Kirkee Cantonment Board. He also welcomed Dr. Jayashree Katare, Additional District Magistrate who took Oath as a member of the Cantonment Board. Shri Bhapkar thanked the President and all members of the Board for their support in carrying out his duties as Vice President. He also thanked the President and all the members for their active participation in fighting against the Corona Virus and in minimizing the positive cases in Kirkee Cantonment area. Shri Bhapkar also brought out that the work of construction of a fullfledged Library in his ward has been completed and requested President Cantonment Board and the CEO to inaugurate the same at the earliest so that it can be made open for the general public. He also brought on record the work of Smashan Bhumi and the efforts taken for getting water supply to Kirkee Citizens from Holkar Water Works with the support of the Hon'ble MP & MLA.
