In continuation to earlier orders with regard to lockdown and easing of restrictions and phase-wise opening of lockdown (Mission begin again) revised guidelines and directives issued for containment of COVID 19 in the State for the period up to 31st March 2021 following orders / guidelines are being issued regarding celebration of Holi / Dhulivandan / Rang Panchami festival in Kirkee Cantonment Area during the recent pandemic situation due to spread of Corona virus: -

Due to recent spike in rise of COVID-19 in the Cantonment area it is being instructed to avoid crowd and accordingly it has been banned to celebrate Holi festival on 28 March 2021 and similarly on 29 March 2021 for celebration of Dhulivandan / Rang Panchami in the public places, hotels, Resorts, Community halls, Mangal Karyalayas, public or private open grounds/places, open plots/places of all Co-operative Housing Societies, roads, grounds, gardens, schools or private or places. As per "My Responsibility" programme even private celebration of the festival be avoided.

All the citizens /residents of Kirkee Cantonment area are requested to cooperate with the Cantonment administration in observing the above orders / guidelines.

It may please be noted that any violations will be dealt strictly as Disaster Management Act, 2005 and suitable action shall be initiated without any further notice.
