**SUB: IMPOSITION OF PENALTY AGAINST THE OFFENDERS FOR PANDEMIC  
SITUATION OF CORONA VIRUS IN KIRKEE CANTONMENT AREA.**

Sir,

It has been observed that there are number of offenders who are not following the guidelines issued by the authorities towards containment of spread of pandemic Corona virus by not wearing masks, not maintaining social distancing, etc while moving within the limits of Kirkee Cantonment area. Also, the second wave of the spread of pandemic situation has already been alarmed by the Authorities.

2. In view of the above you are hereby directed to inspect all the public places like Gymnasiums; Gardens; Libraries; Study rooms/centres; Clinics; Coaching centres; Cinema Halls; Marriage Halls; Schools; Tournaments; Rallies; etc and penalise all such offenders for not observing the guidelines issued for containment of spread of pandemic Corona virus like use of masks, social distancing, spitting, etc.

- c) Strict penal enforcement for non-use of masks; violation of social distancing; etc as declared in the earlier orders. For this HS/GS and Health Staff along with Local Police Officials are hereby authorised to penalise all such offenders.
- d) Kirkee Cantonment Board's official website be updated with all the developments pertaining to containment of spread of Corona Virus in the Cantonment area.
- e) Strict vigilance of all the public places like Gymnasiums; Gardens; Libraries; Study rooms/centres; Clinics; Coaching centres; Cinema Halls; Marriage Halls; Schools; Tournaments; Rallies; etc pertaining to violations of all the protocols for containment of spread of Virus. HS/GS and Health Staff along with Local Police Officials are hereby authorised to penalise all such offenders and initiate strict actions for any negligence on the part of any individual and even result closure/sealing of the premises.
- f) All the Hotspots and containment zones shall be sanitized using hand pumps using proper protective gears.
- g) All the shopkeepers/vendors/residents/buyers to be penalised for non-wearing of masks; non-maintenance of social distancing/yellow foot markings.
- h) It will be responsibility of respective Housing Societies / Residents Welfare Associations to maintain all the protocols and guidelines of containment of spread of the Virus in their respective Societies. It may be noted that for any violation the concerned Committee Members shall also be penalised for such violation in their Societies.
- i) All the teachers of the Cantonment Board's Schools shall be deputed for Contact Tracing. Requisite orders shall be issued for the teachers to report to Dr. Baliwant BACHG Kirkee for performance of contact tracing from time to time.

3. Further, considering the increasing number of positive patients it has been decided that Covid Care Centre established at Kirkee Sports Complex which was discontinued due to reduction in number of positive patients during first wave of spread of Corona Virus; need to be recommissioned with immediate effect. RMO informed that 02 Ayurvedic Doctors; 06 Nursing Staff; 05 Ward Ayahs; 05 Ward Boys and 04 Sweepers would be required to be engaged for the above-mentioned CCC either through contract or adjusted through the existing staff. It was directed by the CEO the required staff may be engaged as suggested by the RMO and the CCC be made operational with immediate effect.

It was further, decided that keeping in view the rapid increase in number of positive patients as far as possible the preference may be given to residents of Kirkee Cantonment area; Cantonment Board's Members and staff. As regards patients outside Cantonment limits may preferably be referred to DCHCs / CCCs / other Hospitals of their choice. This decision is basically in the larger interest of general public / residents of Kirkee Cantonment area.

4. It was also noted that there have been 02 casualties of Covid positive patients who had been referred by the Cantonment Hospital to other hospital during the second wave who had turned to be serious. Accordingly, it was directed that setting up of ICU in the Cantonment Hospital be taken up out of savings of the funds allotted for Covid 19 by the District Authorities under DPDC as resolved vide CBR No. 42 dated 20 Jan. 2021. Further, even some funds have been allotted in SDRF by the

District Collector for undertaking some civil works for the CU in the Cantonment Hospital. Keeping in view the rising number of patients the RMO was accordingly directed to utilise the already received equipments and also to undertake the work of procurement of remaining equipment for ICU and to put the same functional at the earliest. Further, CEE was directed to render all the assistance to the RMO for its early functional.

### COVID MOST URGENT

#### **SUB: MINUTES OF DISCUSSION HELD ON 22 MARCH 2021 FOR PANDEMIC SITUATION DUE TO CORONA VIRUS DUE COVID - 19 IN KIRKEE CANTONMENT AREA.**

The **Most Urgent** discussions on **COVID-19** were convened on 22 March 2021 at 1100 hrs in the office of Kirkee Cantonment Board regarding the matter due to Second wave of pandemic situation for Corona Virus COVID-19 in Kirkee Cantonment area and detection of total 2250 COVID positive patients as on 21 March 2021 and total 237 active cases in the Cantonment area.

Following were the discussions in light of increasing number of active patients having been detected positive for COVID-19 in Kirkee Cantonment area. In light of the following references: -

1. Section 34 (c) & (m) of the Disaster Management Act, 2005
2. Indian Epidemic Disease Act, 1897.
3. Orders of the District Collector and the District Disaster Management Authority vide order no. 901/2020 dated 05 May 2020 regarding appointment of Incident Commander.
4. All the Orders issued by the Ministry of Home Affairs, Government of India and Department of Revenue and Forest, Disaster Management, Relief and Rehabilitation, Government of Maharashtra regarding Containment of spread of Corona Virus in the area.

2. Keeping in view of the increasing number of positive patients in second wave it has been decided to initiate following Preventive measures more strictly and effectively: -

- a) Identification and declaration of Hotspot in the localities where 05 or more than 05 patients have been detected as positive.
- b) Declaration of Micro-containment zones for every positive patient as was done earlier without any relaxation.
