## SUB: DECLARATION OF MICRO CONTAINMENT ZONES IN KIRKEE CANTONMENTAREA FOR SPREAD OF PANDEMIC CORONA VIRUS COVID-19.

Orders of the District Collector and the District Disaster 3. Management Authority vide order no. 901/2020 dated 05 May 2020regarding appointment of Incident Commander.

Meeting held on 06 May 2020 with Chief Executive Officer, 4. ZillaParishad, Pune and other District Health Officials in the office of the Cantonment Board, Kirkee suggesting for declaration of micro-containment zone in the Cantonment area whereby portion of civil area where number of positive cases were detected and releasing other parts of the Cantonment Board.

- 2. I, Pramod Kumar Singh, Chief Executive Officer, Kirkee Cantonment Board and INCIDENT COMMANDER of the Cantonment area considering the present COVID positive patients in Kirkee Cantonment area do hereby declare MICRO-CONTAINMENT ZONES as specified below for effective containment of spread of pandemic Corona Virus COVID-19 in the Cantonment Area with immediate effect i.e. from 26 March2021 for a period of 10 days.
- 3.(A)Portion of Bazar Area, consisting House no.74 Old Bazar, 70-ANew Bazar, Neeta Apartment, 219 Old Bazar, 293 Old Bazar, 52 New Bazar, 212 Old Bazar, 107 Old Bazar, 480 Old Bazar, 3 Old Bazar, 242 Old Bazar, 486-C Old Bazar, Mangalya Society, 78 New Bazar, Kirkee.
- 3.(B)Portion of Bungalow Area, consisting Bungalow No. 30, Burr Road,Kirkee.
- 3.(C)<u>Portion of Range Hills Area, consisting Type I quarters no. 2/2, 67/6; Type- II quarters no.77/10, 16/2, 3/15, 4/6, 89/1, 85/2, 85/8, 90/19; Type D, quarter no.30/4, 14/3, 27/8, 9/6; Type III quarters no. 2/1, 16/2; Type H quarters no. 12/5,Kirkee.</u>
- 3.(D)Portion of Sangamwadi Area, consisting House No. 48, Sangamwadi.
- 4. It may be noted that all the orders, instructions and guidelines issued by Covernment of India, Government of Maharashtra, District Authorities, District Authorities, earlier orders of the Incident Commander shall remain in force till further orders of the Competent Authroity(ies) issued from time to time for the Authority and containment of pandemic Corona Virus COVID-19.

- 5.(B) Nodal Officer & Post for the Micro-Containment Zones at Para 3 (C) shall be Senior General Manager, Ammunition Factory, Kirkee or any other Officer nominated by him.
- 6. For Micro-Containment Zones mentioned at Para 3 above, the concerned authority shall strictly follow all guidelines and protocols issued by the concerned authorities in this regard for 3 (A), (B) & (D)Kirkee Cantonment Board, Kirkee& for 3 (C), Ammunition Factory, Kirkeeshall continue following activities in the above mentioned Micro-Containment Zones:
  - a) Mohalla Clinics or medical tests and screening by the Medical officer.
  - b) Laboratory tests of all the suspected cases.
  - c) Asha, Anganwadi health workers (male & female) shall be deputed for house to house survey.
  - d) Issue of instructions to all the symptomatic cases and their other family members about the Corona Virus.
  - e) Listing of all Government and Private health centres and informing about any detection of positive cases to the Cantonment Hospital.
  - f) All the close contacts of Positive cases shall be observed by medical officer for 28 days.
  - g) The entire contact list at residential area, official place, etc shall be traced and informed to the concerned District Authorities.
  - h) Identification of all the individuals of the contact list for medical examination and also Google mapping of the list.
  - i) Preparation of High Risk & Low Risk list of the contacts of the positive patient be prepared for Home Quarantine and Public Quarantine.
  - Swab test of all ILI/SARI patients identified in the zone.
  - k) Submission of daily list of patients of Government and Private health centres to the Cantonment Hospital.
  - I) Public announcement of Social distancing be made.
  - m) Except for essential services all the other activities shall be closed in the Micro-Containment zone. Concerned Police Station be informed and shall depute sufficient police staff in the Zone.
  - n) All the staff deputed for essential services in the Micro-Containment Zone shall take all the precautionary measures of wearing of mask and social distancing, etc.
  - o) Essential check-up of anybody going out of the perimeter of the Zone.
  - p) Proper sanitization of the vehicles going out of the perimeter of the Zone.
  - g) Proper staff at the check posts in all 03 shifts.
  - r) Display of banners on the check posts informing all the precautionary & preventive measures.
    - Distribution of handbills and public announcement regarding precautionary & preventive measures for spread of Corona Virus.
    - House to house survey by medical team for identification of suspects and other public announcement.
  - u) Public awareness through hand bills, public announcement, newspapers, size local cable network.
    - Establishment of control room in the Micro-Containment Zone.
    - Taking all the Police help and assistance for effective control in the Zone.
